18/10/11- 7i. We have been approached by Friends of St. Leonard's, who are arranging their own party. We will support what they are doing rather than arrange something ourselves.

10/12/11- 6a. Christmas cards had been printed and distributed.

10/12/11- 6b. Sermon Feedback. Resting with CG- will try to get something arranged for this Sunday (Chris B preaching).

10/12/11- 7b. i. Dripping overflow over the cellar steps- has got worse and will be dangerous if it freezes again.

10/12/11- 7b. v. Richard Oliver has cleared leaves from the lower guttering, but does not think that chicken-wire over the hoppers will do any good (our thanks to Richard).

10/12/11- 7f..LMG guided prayer group on 21<sup>st</sup> Jan. Would we like the heating on – 10-12 a.m.? Yes please, although if there are not many it might be held in the Den in Cheddar.
